

## COMMONWEALTH TRANSPORTATION FUND REVENUE REPORT

### January 2026

#### Summary

Commonwealth Transportation Fund (CTF) revenues increased by 4.7 percent (\$20.3 million) in January compared to the same month last year. This increase is primarily attributable to an increase in Motor Fuels Tax and State Sales & Use Tax collections. The growth in these collections is slightly offset by minor decreases in collections on International Registration Plan fees and interest earnings.

#### Motor Fuels Tax

Motor fuels taxes collections increased 6.9 percent in January compared to the same month last year.

The West Texas Intermediate Spot Crude Oil Price average increased to \$60 per barrel in January from \$57.97 in December. The Energy Information Administration's (EIA) forecast for crude oil prices suggests that the price will decrease in 2026 to an average of \$57.7 per barrel from an average of \$69 per barrel in 2025, a decrease of 16.4 percent. This reduction will be caused by a planned increase in oil production from the U.S. and OPEC+ countries.

Real average price of a gallon of regular fuel decreased to \$2.81 in January. The EIA estimates that the increased supply of crude oil will drive the average price of a gallon of gas to approximately \$2.91 in Calendar Year 2026, down from \$3.10 average price in 2025.

#### Motor Vehicle Sales and Use Tax

Motor vehicle sales tax collections increased by 0.9 percent in January.

Total U.S. light vehicle sales decreased to 14.9 million (SAAR) units in January 2026, from 16.0 million (SAAR) in December.

New light-vehicle sales decreased 3.5 percent in January month-over-month, due in part to fewer purchasing incentives and disruptions brought on by a month-end winter storm. According to Kelly Blue Book, the average transaction price (ATP) for a new vehicle decreased 2.2 percent compared to December, but increased 1.9 percent compared to this month last year. Sales of used vehicles, from franchised and independent dealers, increased 4.6 percent in January compared to December, and grew 3.3 percent compared to this month last year. According to the Manheim Used Vehicle Value Index,

wholesale prices were up 2.4 percent month-over-month in January, which is also a 2.4 percent increase compared to this month last year.

According to Cox Automotive, 66,276 new electric vehicles were sold during January, which denotes a decrease of 20.4 percent from December, and a 29.9 percent year-over-year decrease from this month last year. Used EV sales totaled 31,503 for the month, a 20.8 percent increase from December, and a year-over-year increase of 21.2 percent over January of last year. The average transaction price for a new electric vehicle decreased 3.1 percent this month compared to December, and decreased 0.6 percent compared to January 2025. The average transaction price of a used electric vehicle decreased 2.5 percent month-over-month and decreased 5.1 percent year-over-year.

#### State Retail Sales Tax

The transportation portion of state retail sales tax collections increased by 7.1 percent in January.

#### Motor Vehicle Licenses

Motor vehicle registration fee collections increased 1.1 percent in January.
